Three Rivers Park District Foundation maintains internal controls governing the safekeeping of confidential donor information. Ensuring a donor's privacy is vital to the mutual trust between the Foundation and our donors.

Privacy Policy

Three Rivers Park District Foundation (TRPDF) and all donors are bound by the terms of this privacy policy. TRPDF is committed to protecting the privacy of our donors. This privacy policy discloses the privacy practices governing the use of information provided to TRPDF.

The Information We Collect, and How We Collect It

TRPDF may collect personal information such as names, company names, titles, addresses, telephone numbers, e-mail addresses, and payment information from donors. TRPDF may collect personal information submitted from donors via mail, online, email, telephone, or at events and venues where TRPDF is present.

TRPDF may also collect such information by appending from "public records" such as, but not limited to, United States Postal change of address (COA) information and local and state government records. We may also append information concerning the donors' volunteer activities on behalf of the Park District.

By submitting their personal information, donors acknowledge that they have read this privacy policy, understand it, agree to its terms and authorize TRPDF to collect, use and disclose personal information pursuant to the terms of this privacy policy.

How We Use Your Information

The TRPDF uses personal information collected from donors to respond to donor inquiries, process requests for information, issue gift receipts, aid in deciding who receives fundraising solicitations and periodic updates, process donations, organize events, inform donors of new programs and services, and to analyze overall donation patterns for internal budgeting purposes.

Who We Share It With

Unless we have your consent or except as required by law, TRPDF will not share your personal information with any person or entity other than those affiliated with TRPDF, entities acting on behalf of TRPDF, and relevant third parties such as Three Rivers Park District program participants and sponsors.

Notwithstanding other provisions of this privacy policy, we may disclose personal information in special cases when we have found it necessary to identify, contact or bring legal action against someone who may be violating any agreement or may be causing injury to or interference with TRPDF, its donors, or anyone else that could be harmed by such activities.

We reserve the right to disclose your personal information as explicitly set forth in this privacy policy or any agreement agreed to by you, or as otherwise required by government or law enforcement officials. The TRPDF can, and you hereby authorize us to, disclose any information to law enforcement or other parties that the TRPDF in its sole discretion, believes is required or appropriate to comply with the law.

Discontinue Contact Policy

Any person may request not to be contacted by the TRPDF. It is our policy to remove contact information from our mailing list as soon as possible upon request. It is important to point out that we legally cannot remove a name (record) from our database if that record contains information concerning donations, the record is marked to receive no other mailings.

We will not remove names from our mailing list unless the request to take such action is communicated by donors or their authorized representatives. Donors may make this request by direct mail, phone, or email. The records of persons who have made such a request will be maintained to the extent necessary for legal and liability purposes.

Third Party Service Providers

TRPDF contracts with third parties for certain services including, but not limited to: Online donation processing; event registration; email services; GiveMN (“Give to the Max Day”); and Three Rivers Park District. Each of these third parties maintains their own privacy policy and/or terms of use policy.
